3. DEFINITIONS

Aircraft operator

In case of scheduled and charter flights that airline that operates an aircraft under the airline's ICAO or IATA code and its airline code is not present as code-share partner. In case of general aviation that legal entity or individual that aircraft operator which according to Section 12 of Act XCVII of 1995, is included in the register of the aviation authority or, in the case of a foreign aircraft, an operator included in the register of the foreign aviation authority.

Aircraft owner

According to Section 12 of Act XCVII of 1995, an aircraft owner is a person included in the register of the aviation authority as owner or, in the case of a foreign aircraft a person included in the register of the foreign aviation authority as owner.

Aircraft

Any mechanism, the staying of which in the air originates from an interaction with the air different from the effect of the forces of the air on the surface of the earth.

Airport Operator

Debrecen International Airport Kft., a business company, the duty of which – together with other activities – is to administer and manage the infrastructure of the airport as well as to coordinate and control the activities of the different persons at the airport.

Airport user

A natural person or a legal person carrying passengers, postal consignments and/or goods to or from the given airport via air.

Airport

Debrecen International Airport (DEB/LHDC).

Authority

National Transport Authority Office for Air Transport (Hungarian CAA)

Chartered flight

Occasional and periodical flight which flies to and from the Airport not regularly and which are not included in the schedule approved by the aviation authority.

Domestic flight

A flight is considered a domestic flight if its destination in the officially issued flight plan is in the territory of Hungary.

General aviation flight

A flight that does not operate as a scheduled or chartered flight and is not typically engaged in commercial activity.



**Maximum Takeoff
Weight (MTOW)**

The maximum structural takeoff weight of an aircraft on the basis of the certificate of the aircraft's suitability for flying.

Passenger

Any person, excluding on-duty members of the flight and cabin crew, who makes a journey by air. Infants in arms are included.

Passenger aircraft

A flight that carries persons who are included on the Passenger Name List and do not belong to the crew of the aircraft.

**PRM (persons with
reduced mobility)**

Disabled persons and persons with reduced mobility travelling on aircraft, whose rights are regulated by regulation 1107/2006/EC of the European Parliament and of the Council of 5 July 2006.

Scheduled flights

Flights flying regularly to and from the Airport and included in the schedule approved by the aviation authority, the air carrier sells single seats to individuals until the aircraft is full.

State aircraft

The aircraft serving the purposes of the defence, customs, police and border guard authorities.

Transfer passenger

Passengers arriving and departing on a different aircraft, or on the same aircraft bearing different flight numbers..

Transit passenger

Passengers who arrive at and depart from the airport on a flight bearing the same number.

4. CHARGING POLICY

DETERMINATION AND COLLECTION OF AIRPORT CHARGES

4.1 DETERMINATION OF THE CHARGES

Debrecen International Airport Kft., the operator of Debrecen International Airport, shall determine and freely establish the different rates of charges and collect the charges.

All fees indicated in this document are net fees. Ground handling fees of partners shall be subject to 27% VAT in case of territorial scope of Hungarian VAT except in accordance with Article 104 of the Hungarian Value Added Tax Act and Article 148 of the Council Directive 2006/112/EC which means exemption from VAT if the Company carries out mostly international flights.

It is considered the Airline company operating for reward chiefly on international routes, if more than 50% of their annual flights relate to international flights or if the airline company is recognized as such in international agreements on air traffic.

This exemption applies only if the invoice is directly issued to the airline company and the airline holds a valid Air Operator Certificate (AOC).

To ensure the above statement, the User of the Airport must fill the Debrecen International Airport Kft.'s VAT Declaration Form, in which the User of the Airport declares they are entitled being exempted from VAT. (See *15.1 VAT DECLARATION FORM* in the annexes)

4.2 COLLECTION OF THE CHARGES

When using the airport, the charges shall be paid as determined in present document and calculated in EUR. Forms of payment:

FORMS OF PAYMENT	CURRENCY
Credit card (Visa, Mastercard, Maestro, AmEx, Union Pay, JCB)	EUR

It shall be the duty of the operator of the flight to pay the charges for the use of the airport. If the operator cannot be identified, the owner of the aircraft – established by the register number – shall be obliged to pay the charge.

The due charges shall be paid in bank transfer or via credit card.

In special cases, the operator/owner of the aircraft shall request to make the payment in advance at ops@debrecenairport.com.

The following data shall be submitted to Debrecen International Airport Kft. for the *flight request*** at ops@debrecenairport.com:

- the aircraft type and subtype,
- flight number,
- registration number,
- noise certificate of the aircraft
- AOC
- estimated time of arrival and departure,
- MTOW,
- estimated number of arriving / departing passengers,
- VAT Declaration,
- billing info.

** To facilitate the flight requesting process, please fill the Debrecen International Airport Kft.'s Flight Request Form. (See 15.2 *Flight Request Form* in annexes.)

Until the due charges are paid, the airport operator shall be entitled to prevent take-off without prejudice to the safety of aviation. If the airport operator prevents take-off because of non-payment, the operator/owner of the aircraft having failed to pay may not claim damages from Debrecen International Airport Kft.

Except for claims acknowledged by Debrecen International Airport Kft. or based on a final and valid court resolution, the operator of the aircraft is not entitled to offset any kind of actual or presumed claim on any grounds against the charges payable under present Airport Charges Manual.

In case the partner makes the payment in bank transfer, Debrecen International Airport Kft. sends invoices to aircraft operators / owners to the email address(es) specified by the aircraft operator / owner.

Additional charges may apply depending on specific requirements or services requested.

4.2.1 PREPAYMENT

Debrecen International Airport Kft. requests either payment by credit card or prepayment.

Prepayment based on the date in the ground handling request form, Debrecen International Airport Kft. shall prepare the pre-calculation and send it to the airline. In the case of pre-payment, the calculated amount must be transferred to the bank account of Debrecen International Airport Kft. 2 days prior to the flight arriving date.

If the prepayment does not arrive on Debrecen International Airport Kft.'s bank account in time, Debrecen International Airport Kft. shall be entitled to demand the payment of the airport charges on the spot by bank card.

In case of overpaying, Debrecen International Airport Kft. will deduct the remaining amount from the partner's next flight account and settle once in every quarter (this may be waived in individual cases), at which time Debrecen International Airport Kft. will refund the unused amount.

In that case if the total amount of the invoice is higher than what is included in the advanced transfer due to unforeseen events, Debrecen International Airport Kft. shall be entitled to demand the payment of the remaining charges on the spot by credit card.

4.3 GOVERNING LAW

All matters in dispute concerning the legal ground, payment and collection of the charges shall be governed by the laws of Hungary.

4.4 COMPLAINT HANDLING

The user of Debrecen International Airport shall send its comments and complaints about services and billing to ops@debrecenairport.com.

4.5 FREE AIRPORT CHARGES

Aircrafts are exempt from paying airport charges in the following cases:

- Flights operated by Hungarian state-owned aircraft inasmuch as it is not a commercial flight
- Flights of the Hungarian Airforce
- Aircrafts in emergency



- Aircrafts in forced emergency
- Search and rescue flights
- Air plotting flights
- Flights operated in order to calibrate airport navigation equipment

6. LANDING CHARGE

6.1 GENERAL

A fee shall be payable for the use of the landing facilities, provision of rescue and firefighting services and supporting services (e.g: wildlife management, AFIS, lighting services, etc.).

The basic claim of the airport operator to this fee shall arise from the moment the aircraft touches the RWY.

It is the responsibility of the airline or the aircraft operator / holder / owner to inform the airport operator of the basis for assessment - which is the MTOW – by means of an official document issued by the regulatory authority. If the MTOW is not sufficiently documented, the highest known MTOW for this aircraft type will be used for tariff calculations.

6.2 THE BASIS OF ASSESSMENT AND RATES

The assessment basis for the landing fee is grouped as follows:

For aircraft with a MTOW up to 10 000 kgs a fix charge shall be paid per each landing.

For aircraft with a MTOW over 10 000 kgs a per tonne charge shall be paid per each landing

The MTOW of the A/C will be rounded up to the next full 1.000 kg

MTOW (KGS)	LANDING FEE
0 – 2000	17 € / landing
2001 – 10 000	170 € / landing
Over 10 001	13.2 € / tonne / landing

6.3 PRACTISING AND TRAINING FLIGHTS

Aircraft using the airport for the purpose of practising and training approach flights and touch-and-go landings shall be granted 75% discount off the applicable landing fee per each approach and / or touch-and-go landing.

7. PARKING CHARGE

7.1 GENERAL

A charge shall be payable for the use of the parking area of the airport by an aircraft. The claim of the airport operator to that charge shall commence from the moment the aircraft has been parked or is being moved to the parking position at airport apron stands or designated bays assigned for aircraft parking and shall end when the aircraft starts taxiing from its parking position to the holding point.

7.2 THE BASIS OF ASSESSMENT AND RATES

The assessment basis for the parking charge is grouped as follows:

The first 60 minutes of parking on apron or in parking bay is free; further periods shall be charged as:

DURATION	PARKING CHARGE
< 30 days	0.35 € / tonne / hour
30 days <	0,25 € / tonne / hour*

Parking shall be charged upon completion of parking; each started hour shall be considered as a new hour to be charged.

*Before the aircraft is parked for a period of time, which will probably last longer than 30 consecutive days, a special agreement can be made between the aircraft owner and airport authorities. Special agreements are also to be made with the airport authorities in the case of an accident.

8. NOISE CHARGE

8.1 GENERAL

Debrecen International Airport Kft. would like to incentivize airport users to use aircraft with lower environmental emissions by applying the noise component related to the landing charge.

8.2 THE BASIS OF ASSESSMENT AND RATES

The amount of the noise charge (Z) shall be calculated on the basis of the following formula:

$$Z = A * K * N * M$$

Where "A" is the base charge. A = EUR 5,00/movement, "K" is the category factor.

The amount of the noise component is proportionate to the noise emission, therefore the principle of output-proportionate adequacy shall be fulfilled by classifying the planes into four categories. According to the noise level indicated in the noise certificate, aircraft fall under the following categories:

- The aircraft whose noise levels are expressed in terms of EPNdB units of measurement in their noise certificates shall be classified on the basis of the flyover noise level indicated in the noise certificate in the case of take-offs, and on the basis of the arithmetical mean of the noise levels indicated in the noise certificate in respect of the approach and lateral reference points in the case of landings:

- For aircraft whose noise levels are indicated in dB(A) units of measurement in the noise certificate, in the case of take-offs and landings:

- For helicopters whose noise levels are indicated in SEL (A) units of measurement in the noise certificate, in the case of take-offs and landings:

On the basis of the above classification, the value of "K" shall be the following:

"N" is the factor related to the parts of the day

Daytime (06:00-22:00)	Evening (22:00-24:00)	Morning (05:00-06:00)	Night Time (24:00-05:00)

The hours shall be understood in local time.

"M" is the factor related to the operations. The rate of the noise component must be determined separately for take-offs and landings.

TAKE-OFF	LANDING
0.91	1.1

Debrecen International Airport Kft. shall consider the data indicated in the noise certificate as of the date of receipt of the noise certificate.



9. SECURITY CHARGE

9.1 GENERAL

Debrecen International Airport Kft. will collect the Security Charge from the airport users for every departing.

Security charge includes the security screening of the passengers, crew and bags, protection of the aircraft and the security restricted area.

9.2 THE BASIS OF ASSESSMENT RATES

The basis of assessment for the Security Charge to be paid shall be the number of departing passengers.

CHARGE	QUANTITY
2.4 €	/ departing passenger

Not included of the basis of assessment are:

- Children under two years
- Transfer passengers*
- Transit passengers*
- Persons having government request status connected with a 100 % exemption from the air fare.
- Persons whose presence aboard an aircraft is absolutely necessary during training, work-, test- and trial flights.
- Persons whose presence aboard an a/c is absolutely necessary during flight rescue and flight ambulance operations in performing their medical tasks (e.g. doctors, medical personnel).

*Transit and transfer passengers and their bags whose go through security screening shall be charged.



10. PASSENGER SERVICE CHARGE

10.1 GENERAL

For the use of the passenger terminal buildings and other airport infrastructures, including all their facilities and installations by departing passengers and for the implementation of environmental measures a charge shall be payable.

Passenger service charge includes prm services like personal assistance, ambulift usage, etc.

For determining the basis of assessment, the flight operator or the aircraft holder or the air carrier or the aircraft owner shall have to provide the airport operator with adequate data.

The provision of passenger handling counters is not included in this charge.

10.2 THE BASIS OF ASSESSMENT RATES

The basis of assessment for the passenger service charge to be paid shall be the number of departing passengers. For passengers, who use the terminal building the charge shall be:

CHARGE	QUANTITY
23 €	/ departing passenger

Not included in the basis of assessment are:

- Children under two years
- Transfer passengers*
- Transit passengers who are using the terminal building including its facilities and installations in the course of a technical a/c failure connected with a change of a/c.
- Transit Passengers who use the passenger terminal building during the transit- stop of the flight.
- Persons having government request status connected with a 100 % exemption from the air fare.
- Persons whose presence aboard an aircraft is absolutely necessary during training, work-, test- and trial flights.



- Persons whose presence aboard an a/c is absolutely necessary during flight rescue and flight ambulance operations in performing their medical tasks (e.g. doctors, medical personnel).

*Transfer passengers whose use the terminal building and its facilities and installations shall be charged.



11. BAGGAGE HANDLING SYSTEM CHARGE

11.1 GENERAL

Debrecen International Airport Kft. will collect the following baggage handling system charge from airport users for the use of the baggage handling system including the use of baggage conveyors on arrival and departure side as well as baggage forwarding systems at the check-in desks.

11.2 THE BASIS OF ASSESSMENT RATES

The charge is not applicable in case the flight does not transport any arriving or departing baggage. In case of flights transporting only arriving passengers, only the fixed fee is charged.

The basis of assessment for the baggage handling system charge to be paid shall be the number of checked baggage:

CHARGE	QUANTITY
28 € fixed fee	arriving / departing flight
0.7 €	/ departing checked baggage



12. PASSENGER HANDLING COUNTER CHARGE

12.1 GENERAL

For the use of the passenger check-in and passenger boarding infrastructure including all their facilities and installations (including check-in desks, checked baggage scales, computer systems, boarding gate installations, displays) by departing passengers.

12.2 THE BASIS OF ASSESSMENT RATES

The basis of assessment for the passenger handling counter charge to be paid shall be the duration of time spent using the installations.

CHARGE	QUANTITY
17.5 €	30 minutes / check-in counter (boarding gate usage included)



13. FIRE BRIGADE ON RAMP

13.1 GENERAL

Debrecen International Airport Kft collects the following Fire brigade on ramp charge from airport users who require the insurance of the aircraft by firefighters on departure and / or arrival, as well as an aborted take-off.

13.2 THE BASIS OF ASSESSMENT RATES

The basis of assessment for the Fire brigade on ramp charge to be paid per requests of this service.

CHARGE	QUANTITY
80 €	/ case

14. INCENTIVE SCHEME

General conditions for using benefits and discounts

- Discounts are only available on scheduled departing flights that are open to public booking.
- To qualify for discounts aircraft operators shall submit a claim by providing relevant information at the end of each discount period, but no later than one year after each year of operation. Discounts do not oblige DIA Ltd. to make any payment from the incentives.
- Any rebate will be credited following a given year of operation or discount cycle in the subsequent period, to the invoices issued by Debrecen International Airport Kft.
- Discounts given from the passenger service charge apply exclusively to passengers departing directly from the airport, excluding transfer passengers.
- The maximum discount cannot exceed the total 100% of the passenger service charge, and 80% of the landing charge invoiced.
- Incentives can only be granted by offsetting the amount of the discounts against the overdue debts owed to Debrecen International Airport Kft.
- Debrecen International Airport Kft. is entitled to offset the amount of the discounts accordingly. The incentive shall be valid and may be used no later than two calendar years from the end of the period to which the incentives relate. After this two-year period, the incentive expires and the airline loses the right to use it.

Conditions:

- The airline must operate a minimum of two times per week to a new destination for at least 12 calendar months.
- May an airline launch multiple flights to the same new destination within the first operational year, the discount shall apply to all flights.
- Discounts can be claimed after the first operational year and then after each consecutive 365-day period. For the discount to apply, each relevant year constitutes an independent incentive period.
- May an airline resume operation to a destination that was previously in the network, the airline shall become eligible for the discount only if at least two consecutive schedule periods have passed since the cessation of operations to that destination and no other airline operates flights on the same route.
- The “new destination discount” cannot be combined with the “discount for replacement of discontinued routes”.

14.2. DISCOUNT FOR REPLACEMENT OF DISCONTINUED ROUTES

Conditions:

- The "discount for replacement of discontinued routes" cannot be combined with the "new destination discounts".
- The airline must operate to the discontinued destination for at least 12 calendar months, with an average frequency of at least two times per week.
- Replacement of a discontinued route means an airline starting operation to an airport where no other airline operates from and where another airline has ceased operations on that route in the current schedule period or the preceding schedule period.

14.3. DISCOUNT FOR NEW PERIODIC OR SEASONAL FLIGHTS

Conditions:

- The airline must operate to the new destination for at least two consecutive summer or winter schedule seasons for at least 3 months in each year with a minimum of 20 flights per year.
- May an airline resume operation to a destination that was previously in the network, the airline shall become eligible for the discount only if at least two consecutive schedule periods have passed since the cessation of operations to that destination and no other airline operates flights on the same route.

14.4 DISCOUNT FOR FREQUENCY INCREASE

	YEAR 1	YEAR 2	YEAR 3	YEAR 4	YEAR 5
Landing Charge	80%	75%	50%	50%	25%

Conditions:

- Frequency increase means reaching a minimum of 20 departing flights in a specific period by a certain airline on the respective route.
- No reduction shall be conducted in total capacity for the respective route in the same schedule period compared to the previous year. May the capacity be reduced, the airline shall not be eligible for the discount.
- The discount applies to a certain destination, the eligible period spans from the beginning of the current summer or winter schedule period until the end of the following winter or summer schedule period.
- The discount is applicable for both annual and seasonal operations.

- Airlines may receive this incentive from Debrecen International Airport Kft. based on the passenger service charge paid by the airline.
- In case of launching a new destination, after the first 12 months the discount that is equivalent to the total number of departing passengers is settled as a lump sum. Any previously credited discounts during the year are deducted.
- The amount of the discount depends on the number of departing passengers excluding children under the age of 2, for the given calendar year.
- Debrecen International Airport Kft. reserves the right to offset the aforementioned amount against all outstanding debt of the airline towards Debrecen International Airport Kft.
- The discount is not tiered. If the airline reaches a specific tier during the incentive period, the discount associated with that tier applies to the total number of departing passengers reached during the incentive period.
- The credit for achieving the specified maintenance level incentive applies at the end of the given calendar year, considering the total number of departing passengers for the entire calendar year.

Conditions:

- The airline must operate to the discontinued destination for at least 12 calendar months, with an average frequency of at least two times per week.
- The extent of the discount depends on the capacity utilization ratio derived from the combined number of departing passengers (excluding children under the age of 2) and the total capacity of departing aircraft for a given calendar year.
- The airline is obligated to provide Debrecen International Airport Kft. with the information regarding the exact physical seat count for each aircraft operated to the airport per schedule period in advance. Without this information Debrecen International Airport Kft. calculates the utilization ratio using the highest capacity of the respective aircraft type.
- The discount is not tiered. The extent of the discount corresponds to the achieved tier during the incentive period.
- The credit for capacity utilization incentive is given to airlines whose total annual aircraft movements in the given calendar year exceed 85% of the combined aircraft movements of the preceding year.
